05. Sealed bids may be dispatched either by registered post or hand delivered to the following on or before 2.00p.m. **13.03.2024**. Late bids will be rejected. Bids will be opened soon after the closing. Suppliers or their authorized representatives are requested to be present at the opening of bids.
06. Offers shall be marked with the **Contract No** on the top of left Hand corner of the envelope.
07. Bid shall be valid up to 91 calendar days from the date closing of the bid & bid shall be accompanied by a bid security, (valid 28 calendar days beyond the bid validity period) for the amount mentioned in bid document. Any bid not accompanied by a valid bid security will be rejected.
