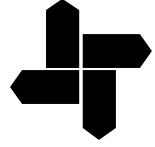

1. The Chairman, Expressway Operation Maintenance & Management Division Procurement Committee, on behalf of the Road Development Authority (RDA), invites sealed bids from eligible and qualified bidders for the works described below:-

3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be currently registered with the Construction Industry Development Authority (CIDA) for **C6 or above** grade in **Highway Construction**.

5. The Pre-Bid meeting will be held at **11:00 hrs** on **26.03.2024** at the office of the Director (EOM&M D), Road Development Authority, Kahatagahahena, Walgama, Bandaragama and a site visit will be arranged immediately thereafter if necessary

A complete set of Bidding Documents in English language shall be purchased by interested bidders on submission of a written application with the registration certificate issued by Registrar of Public Contracts under the Act No. 3 of 1987, Department of Registrar of Companies for the contract to the **Director, Expressway Operation, Maintenance & Management Division** from **11.03.2024** until **01.04.2024** during 09:00 hrs to 14:30 hrs upon payment of a non-refundable fee of **Rs. 4,000.00 + Government Taxes**. The method of payment will be in cash.
7. **Each** Bid shall be accompanied by a Bid- Security obtained from a reputed bank acceptable to the Employer for an amount given in the Bidding Data. **Bid- Security shall be valid until 30.07.2024.**

Bid shall be delivered in **duplicate** to the **Chairman, Director EOM&M Procurement Committee, C/o** Director (EOM&M D), Road Development Authority, Kahatagahahena, Walgama, Bandaragama. on or before **14:00 hrs** on **02.04.2024**. Late bids will be rejected. Bids will be opened soon after the closing, in the presence of the bidder's representatives who choose to attend.
