3. Bidding will be conducted through National Competitive Bidding Procedure (NCB). Since the Estimated Value of work to be performed under this procurement (excluding VAT and other taxes) is below Rs 50 Mn., **Regional Preferences** and CIDA grade preference shall apply as stipulated in Public Finance Circular No. 04/2016(iii).
4. To be eligible for contracts award, the successful bidder shall not have been blacklisted and shall meet the following requirements C6 & C5 in Road Construction work.
5. Interested bidders may obtain further information from Provincial Director's office, North Central Province, Road Development Authority, Anuradhapura (025 2222115) and inspect the bidding documents at the Same Office as per the given deadline in clause 6 below.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the Provincial Director's office, North Central Province, Road Development Authority, Anuradhapura. From 04.04.2024 until 17.04.2024 from 9.00 hrs to 15.00 hrs. Upon payment of a non-refundable fee of Rs. 4,130.00, the method of payment will be Cash.
7. Bids shall be delivered in one Envelop inclusive original and duplicate to the address below on or before 14.00 hrs in 18.04.2024. Bids will be opened soon after closing in the presence of the bidders' representatives at following address. Late bids will be rejected.
8. Bid validity period shall be until 03 July 2024 and all bids shall be accompanied by an unconditional Bid Security (According to the given format) valid until 31 July 2024.
