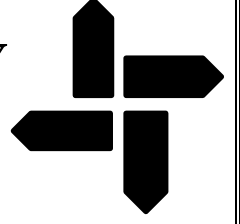

01 Bidding documents will be issued from 08/04/2024 until 22/04/2024 from 9.00 a.m. to 3.00 p.m. upon payment of a nonrefundable tender fee of Rs. 2,500.00 (Including SSCL & VAT) at the Executive Engineer's Office, Road Development Authority, Sri Sumangala Road, Kalutara North.

02 Bids shall be valid up to 77 Calendar days from the time of closing of the bid.

03 Bids security should be valid up to 91 Calendar days from the time of closing of the bid.

04 Bids must be submitted by a Bid security for the above mentioned period from a reputed bank, for the amount stated above. **Any Bid not accompanied by a valid Bid Security will be rejected.**

05 Pre bid meeting will be scheduled on 09/04/2024 followed by site visit at 10.00 a.m.

06 Sealed Bids, addressed to The Chairman, Regional Procurement Committee, Executive Engineer's Office, Road Development Authority, Sri Sumangala Road, Kalutara North be dispatched either be sent by registered post or be deposited in the Tender box kept in the office of Executive Engineer's Office, Road Development Authority, Kalutara at or before 02.00 p.m. on 18/04/2024.

07 Bids will be opened immediately after the closing of the Bids at the office of the Executive Engineer, Road Development Authority, Sri Sumangala Road, Kalutara North. Bidders or their authorized representatives are requested to be present at the opening of the bids.

08 The late delivered Bids will not be accepted and returned to the bidder unopened.

09 Bidders shall mark the Road name and Contract number on the top of left Hand corner of the envelope.
