In the event, a bidder submits bids for more than one contract package and the bidder becomes successful for more than one contract package (lowest substantially responsive), RDA shall assess its capacity to meet aggregated qualifying requirements for value of liquid assets.
9. Each bid shall be accompanied by a Bid- Security for an amount given in the table. Bid Securities shall be valid up to 30/08/2024.
10. Bids shall be valid from 91 days from the bid closing date.

Bids shall be delivered in duplicate to the Chairman, Road Development Authority Procurement Committee, C/o Director General, Road Development Authority, Procurement Division, 4<sup>th</sup> Floor, “Maganeguma Mahamedura”, 216, Denzil Kobbekaduwa Mawatha, Battaramulla on or before 14:00 hrs on 03/05/2024.
