- 5. The Pre-Bid meeting will be held at 13.15 pm on 28.05.2024 at the office of the Deputy Director General (Procurement), Road Development Authority, 04th Floor, Maganeguma Mahamedura, Denzil Kobbekaduwa Mw, Battaramulla and a site visit will be arranged immediately thereafter if necessary.

A complete set of Bidding Documents in English Language shall be purchased by <u>interested</u> bidders on submission of a written application to the **Deputy Director General**, **Expressway Operation**, **Maintenance & Management Division**, Road Development Authority, Kahatagahahena, Walgama, Bandaragama from **09.05.2024** until **03.06.2024** during <u>**09.00** hrs to 14.30 hrs</u> upon payment of a Non-refundable fee of Rs. 27,500.00 + Government Taxes for the contract. The method of payment will be in cash. As per the **Public Contract Act No. 03 of 1987**, the **Agent and Successful winners of the tender shall be registered in the Department of Registrar of Companies**.
- Each Bid shall be accompanied by a Bid Security obtained from a reputed bank acceptable to the Employer for an amount given in the Bidding Data. Bid – Security shall be valid until 01.10.2024.
