1. The Chairman, Procurement committee, Chief Engineer's Office, Road Development Authority (RDA), Galle invites sealed bids from eligible and qualified bidders for the project described below.

2. Bidding will be conducted through the National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be currently registered with the Construction Industry Development Authority (CIDA former ICTAD).
4. Qualification requirements to qualify for contract award include specially in **Highway construction**.
5. Interested bidders may obtain further information from Chief Engineer's office, Road Development Authority, Fort, Galle (Tel/Fax : 0912234891) and inspect the bidding documents free of Charge at the above address from 09 00 hrs to 16 00 hrs of working Days.
6. As per the public contract act No. 3 of 1987, the bidders **of the tender shall be registered in the Department of Registration of Companies**.

A complete set of Bidding Documents in English language may be purchased by interested ICTAD registered bidders in Southern Province on the submission of a written application to the Chief Engineer, Chief Engineer's office, Road Development Authority, Fort, Galle **from 13.05.2024 until 27.05.2024 from 09 00 hrs to 15 00 hrs** upon payment of a non-refundable fee of **Rs 2,500.00** for each (Exclusive of all taxes).

Sealed bids may be dispatched either by registered post or hand delivered in **duplicate** to the Chief Engineer, Chief Engineer's office, Road Development Authority Fort, Galle on or before **14:00 hrs on 28.05.2024**. Late bids will be rejected. Bids will be opened soon after the closing in the presence of the bidders' representatives who choose to attend.
9. Offers shall be marked as the "Construction of Retaining Wall on Galle Wackwella Road & Contract number "on the top of left Hand corner of the envelope.
10. Bids shall be valid up to **26.08.2024**
11. All Bids shall be accompanied by a Bid-Security for an amount given in the table above. Bid Security shall be valid up to **23.09.2024**. Any bid not accompanied by a valid bid security will be rejected.
