3. Bids must be accompanied by a bid security mentioned in the bidding document. The Bid Security shall be in a form of unconditional bank guarantee obtained from a reputed bank in favor of the Deputy Director General, Expressway Operation, Maintenance & Management Division, Road Development Authority, Kahatagahahena, Walgama, Bandaragama. Any bid not accompanied by a valid Bid Security will be rejected.

Each set of Bidding Documents in Sinhala language shall be purchased by interested bidders on submission of a written application to the **Deputy Director General (EOM&M Division), Road Development Authority, Kahatagahahena, Walgama, Bandaragama and Additional Director, EOM&M Division, Beliatta Interchange from 08/05/2024 until 21/05/2024 during 09:00 hrs. to 14:30 hrs.** upon payment of non-refundable fee of Rs. 2,500.00 + applicable Taxes (Rs. 3025.64) .
5. Bid shall be delivered to the **Deputy Director General (EOM&M Division), Road Development Authority, Kahatagahahena, Walgama, Bandaragama** on or before **10:30 hrs. on 22/05/2024**. Late bids will be rejected. Bids will be opened soon after the closing, in the presence of the bidder's representatives who chooses to attend.
