NOTICE OF AWARD

- 1. The Government of Sri Lanka has applied for a loan (US \$ 40 mm) from the OPEC Fund for Development (OFID) towards the cost of the Miscellaneous Foreign Aided Projects (MFAP) and a part of this loan will be utilized for payments under the Contract named above.
- 2. The Road Development Authority ("the Employer") invited separate sealed bids on Single Stage Two Envelop Bidding procedure from eligible bidders for the said project. Six Bids were received at the deadline for submission on 24th September 2021 at 14.00hrs for the above Contract package. Technical Bids were opened at 14.15hrs on the same day and the evaluated substantially responsive technically qualified Bidders are as follows.
