- 1. The Democratic Socialist Republic of Sri Lanka has signed a loan agreement with the SAUDI Fund for Development (SFD) towards the cost of the Road Network Development Project carried out by the Miscellaneous Foreign Aided Projects (MFAP) Division. Part of the loan will be used for payments under the contract named above.
- 2. The Road Development Authority ("the Employer") now invites separate sealed bid from eligible bidders for the Reconstruction of Kurinchakerny Bridge. The construction duration for the package is 24 months.

The International Competitive Bidding will be conducted in accordance with Single Stage One Envelope Bidding Procedure with post qualification.

- 3. Eligible bidders must meet the following general & specific criteria:
 - (i) Pending Litigation shall not represent more than 50% of the bidder's net worth
 - (ii) The bidders net worth within last 5 years shall be positive
 - (iii) General experience in construction contracts within last five years
 - (iv) Average annual construction turnover (AACT) within last 3 years, financial resources, and specific construction experience within last 5 year as given in the table below.

- (i) Personnel: the bidder must demonstrate that he has the personnel for the following key positions for the project: (i) 1 Project Manager (Professionally Qualified Civil Engineer with 10 years total & minimum 5 years experience in similar work); (ii) 1 Material Technician NVQ6 (NDT) or Equivalent with 8 years total & minimum 4 years experience in similar works. (iii)1 Quality Assurance Manager BSc Engineering Degree or Equivalent with 08 years total and minimum 04 years experience in similar work.
- (ii) Equipment: The Bidder must demonstrate the availability of key equipment listed bellow through presentation of proof of ownership or proof of intention to lease or rent with a provision that the equipment will remain on site as per the contract.

 - (i) Write to address above requesting the bidding documents for the Contract Package Nos. RDA/MFAP/ICB/SFD-2/12, Improvement projects in Miscellaneous Foreign Aided Project (MFAP).
 - (ii) Pay a non-refundable fee of Sri Lankan Rupees (SLR) 100,000.00 (without VAT) or US \$ 310.00 by bank draft in favour of the "Secretary, Ministry of Ports & Highways, Saudi Funded Road Network Project" in respect of the bidding document for the project.
