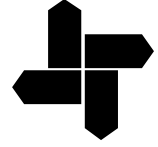

1. The Chairman, Road Development Authority Procurement Committee, on behalf of RDA invites sealed bid from eligible and qualified bidders for the purchase of 1150 MT Bulk Bitumen 60/70 for all RDA Asphalt Plants.
2. Bidding will be conducted through National Competitive Bidding Procedure.
3. Complete set of Bidding Documents in English language may be purchased by interested bidders on submission of a written application with the registration certificate issued by Register of Public Contracts under Act No. 3 of 1987, Department of Registrar of companies for the contract from the Director (Procurement), Procurement Division, Road Development Authority, 4<sup>th</sup> Floor, "Maganeguma Mahamadura", No.216, Denzil Kobbekaduwa Mawatha, Koswatta, Battaramulla from 04/01/2024 until 23/01/2024 during office hours from 9.00 hrs to 15.00 hrs upon payment of non refundable document fee of Rs 20,000.00 (inclusive of VAT) by depositing to the Bank of Ceylon - Corporate Branch Account Number 0000001943 in favour of the Director General, Road Development Authority.

The original payment slip should be produced when purchasing the Bidding Document.

bids will be rejected. Bids will be opened soon after closing in the presence of the bidder or representative who chooses to attend.

5. All Bids must be accompanied by a **Bid- Security** and shall be **valid up to 22/05/2024**.

6. Bids shall be **valid for 91 days**.
