1. The Chairman, Road Development Authority Procurement Committee, on behalf of RDA invites sealed bid from eligible and qualified bidders for the purchase of 1200 MT Bulk Bitumen 60/70 for all RDA Asphalt Plants.
2. Bidding will be conducted through National Competitive Bidding Procedure.
