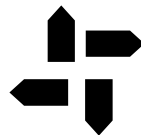

3. Pre Bid Meeting is scheduled to be held at the **Provincial Director's Office(NWP), Road Development Authority, Puttalam Road, Kurunegala** at **10.00 hrs** on **06.03.2024** and site visit will be arranged on the same day.
4. **It is Mandatory for bidders to register under public contracts act no.03 of 1987. For each contract (for contract value is more than 5 million) separately.**

A complete set of bidding documents in English language may be purchased by interested bidders on the submission of written application, **registration form the Department of the Registrar of companies and CIDA** book to the **Provincial Director (NWP), Road Development Authority, Puttalam Road, Kurunegala** from **28.02.2024 until 13.03.2024 (only week days)** from **9.00 hrs. to 15.00 hrs.** upon payment of a non-refundable Tender fee (Above Table) for each document (**Excluding VAT**).
6. Bids mentioning the name on top left hand corner with separate envelopes shall be delivered in duplicate by registered post or hand to the **"The Chairman, Provincial Procurement Committee (NWP), Road**

**Development Authority, Kurunegala”, on or before 14.00 hrs. On 14.03.2024 late bids will be rejected.**

7. Bids will be opened soon after closing, in the presence of the bidders or their representatives who choose to attend.
8. Bids shall be valid up to **13.06.2024**.
9. Bid shall be accompanied by a Bid Security. Bid Security shall be valid up to **11.07.2024**.
