- 5. Bid must be accompanied by **a bid security valid up to 18.07.2024**. Any Bid not accompanied by a valid Bid Security will be rejected.

The original payment slip should be produced when purchasing the Bid Documents. As per the public contract act.no.3 of 1987, the agent and successful winners of the tender shall be registered in the Department of Registrar of companies. **Bid received will be closed at 2.00 p.m. on 22.03.2024**
