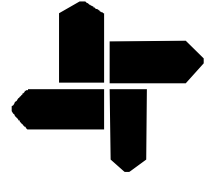

NOTICE OF AWARD

The Democratic Socialist Republic of Sri Lanka has applied for a loan from Saudi Fund for Development (SFD) and SFD has agreed to provide funding of US\$ 60 Million and US\$ 10 Million from GOSL to Rehabilitate and Improve Peradeniya - Badulla- Chenkaladi Road (A05) from Bibile to Chenkaladi under BadullaChenkaladi Road Improvement Project (BCRIP) and after completion of above section part of that fund (balance amount) will be utilized to rehabilitate and improve Ampara Uhana Mahaoya Road (A027) from Keviliyamadu to Mahaoya(33+000km to 58+000km) with the consent of the Donor agency.

The selection of the consultant is done using Quality and Cost Based Selection (QCBS) method (70:30) under NPA guidelines and following **eight** interested firms submitted the proposals.
